Mr. Gast, Ms. Lee, Ms. McMullen, Mr. Rea and Mr. Reeb were present. The President called the meeting to order at 6:07pm.

Safety Plan 2022-2023 School Year

- Dr. Laurie Banks, Superintendent, introduced Springfield Township Officer Kevin Taylor as the new Finneytown Local School District SRO for the 2022-2023 school year. Officer Taylor is a 21-year veteran of the police force and has 9 years experience as an SRO.
- Mr. Grant Anderson, Director of Operations, discussed the District Safety Plan:
 - o The plan is updated each year
 - o Each hazard or threat has a unique age-appropriate plan for the Elementary and Secondary
 - o Prevention is a key focus of the plan
 - Response functional content areas include: closing school, emergency communication, evacuation, family reunification, lockdown, medical response, mental health services, rapid assessment, reverse evacuation and shelter-in-place
 - o Response hazards and threats anticipated include: active shooter/active aggressor, bomb threat, bullying, bus accident, fire, hostage, medical blood borne pathogen, severe storm, tornado, terrorism, chemical accident, civil disturbance, dam failure, death, earthquake, explosion, flood, gas leak/outage, injury/health emergency, lost child, pandemic, nuclear incident, power outage, sexual assault/abuse, unidentified substances/illicit drugs/ water outage/restriction, winter storm and ice storm.
- The plan involves collaborative input from internal and external sources. Involved stakeholders include district administration, police, fire department, and Shawn Riley, Safety Consultant HCESC.
- The district uses Navigate 360 as its safety plan software and reporting requirements.
- State law requires 3 safety drills involving Springfield Township per year
- Critical staff receive Crisis Prevention and Intervention (CPI) training

- Mr. Grant Anderson, Director of Operations, discussed a building safety Q&A based upon questions submitted by Board of Education members.
