The Finneytown Board of Education met in special session on Friday, October 15, 2021, in the Administrative Office Conference Room, 8916 Fontainebleau Terrace, Cincinnati, OH 45231. Mr. Engleman, Mr. Gast, Ms. Gordon and Mrs. Rebman were present. The President called the meeting to order at 5:05pm.

71-21 Mrs. Rebman moved, seconded by Mr. Engleman, that the Board dispense with the opening ceremony and approval of minutes from the September 20, 2021. The President declared the motion passed.

72-21 Ms. Gordon moved, seconded by Mr. Gast, that the Board move to Executive Session, in accordance with ORC 121.22(G)(1) for the purpose of considering the appointment of a public official.

RC: Mr. Gast, yes; Mrs. Rebman, yes; Ms. Gordon, yes; Mr. Engleman, yes. The president declared the motion passed.

The Board entered Executive Session at 5:07pm.

The Board returned to Special Session at 5:50pm.


Oath of Office – New Board Member Appointed for Remainder of Term
