Student Update

- A panel of high school students discussed the following:
 - Highlights from the last month included: Adams Family Musical, spring sports kick off, H.S. Band and Orchestra Concert, and a \$5000 donation from the Make A Wish Foundation to the Finneytown HS band on behalf of Grady Laird.
 - It was suggested the district email Finneytown HS students to inform them about the Whitaker site development possibilities and seek their input.

Finneytown Elementary Family Student Presentation

- The Finneytown Elementary Family program was formed last year by Teacher, Patti Ferris, with the support of Principal, Meredith Baker, and other staff, to create a family-like atmosphere.
- All students and teachers are assigned to a family group.
- Students shared the goals of the program:
 - To connect the lower grades (K-3) to the higher grades (4-6),
 - To help every kid and adult feel a part of something outside of their homeroom class,
 - To train 5th and 6th grade students to become leaders,
 - To encourage everyone to think more about others
- Meetings are held once a month to complete a service learning project.
- Board members were invited to the next Finneytown Elementary Family Meeting at Finneytown Elementary on April 28th from 9:50am 10:20am.

Administrative Report

Dr. Laurie Banks, Superintendent – discussed the following:

- ProAction Cafe Our last meeting was March 16th.
 - We are working on a writing project called "We Are Finneytown", which we intend to publish and make available to welcome new families. Anyone may submit a passage or story on what Finneytown means to them for consideration.
 - We are also forming a Welcoming Team to reach out to new and existing families in our school district.
- Lunch Fees Personal phone calls to families with large past due lunch balances are being made to obtain payment and get eligible families signed up for the Free and Reduced Lunch Program
- Educational Visioning Seven district representatives attended a Workshop hosted by the Ohio Facilities Construction Commission in preparation for the design process. Takeaways included: Next Practices versus of Best Practices, PBL learning the way of the future, and more.
- Whitaker Site Possibilities Our next community conversation special meeting is scheduled for 6pm on Thursday, April 13th. The administration continues to have conversations with attorneys and township about what those possibilities are. Feeback from the February 28th meeting is being used to design the next conversation. A community update will be sent out with the location.
- Spring Break is next week.
- Testing season begins the week after Spring Break. Attendance, eating well and a good night's sleep will be very important.
- The district will hire Ariel McCoy to fill the afterschool choir director supplemental position. She was hired for the Adams Family musical choral position.

<u>Public Address</u> Bob Hauer

> My wife's family has supported the Finneytown Local School District for over 150 years, back to the days it was a one-room schoolhouse. We live on Winton a half mile from Galbraith and North Bend Roads, on property that abuts the Whitaker site. Every morning traffic backs up bumper to bumper at least three-quarters of a mile on Winton going south. Traffic backs up to North Bend for an hour and a half every evening. The projected 160 units will house 350-500 people and 350-500 automobiles, the equivalent of a small village. I have checked with 3 builders and 4 realtors, all of whom say this project does not belong on that site. There seem to be three objectives: to make a lot of money for the school, make a lot of money for the developer and architect, then inform the neighbors. We are very unhappy you have pushed this project without informing, or getting any feedback from the neighborhood that it affects the most. We are told this project will devalue properties in the neighborhood. The school district and township will make a lot of money at our expense. We are very unhappy with the project. If this goes through, we must work very hard to make sure that we do not approve any more school levies. We don't want to do that. We have been promoting the school for a long time and are happy with the job you're doing. The additional traffic is not acceptable. We hope that you reconsider this. Thank you.

Shelly Westerfield

I'm a teacher at Finneytown Elementary. I have 28 years in the district and serve as President of the Finneytown Education Association (FEA). On behalf of our members, I'm here to first express appreciation for the sentiment behind the Paid Parental Leave (PPL) MOU with the FEA on the agenda. We all agree that bonding and bringing home a child to a family is overwhelming, a joy and very important. I acknowledge the initial conversation with members of the Board was a starting point for the PPL MOU. However, not having worked together on it, we request a work session with the board, administrators, and members of both unions. Some items are troublesome: the eligibility requirements, the combined use of sick leave and PPL, and the potential cost to the district. We request the vote be postponed until more clarification is provided. Thank you.

Michael Hamel

My topic, situational awareness, has been made more special because of the situation that is upon us. We are at a spot in this community where we need to be situationally aware of what is going on around us. Klaus Schwab says we will own nothing and be happy for it. There's a situation called Agenda 21, which is now Agenda 2030. I brought this to your attention before. This project is exactly what Agenda 2030 embodies – mass housing in small areas, destroying suburban areas...for what purpose? For money, greed, destroying community. Throughout history, people have interceded for their citizenry. The 12 feudal barons that met at Runnymede to petition King John, hence, the Magna Carta. 1776 was an extension of the Magna Carta, allowing us to become the country we are. We now have a situation where you, as our representative board members, must intercede on our behalf. Vote this property situation down. It doesn't belong here. It will do nothing for us. I'm asking you to please stand against the tyrannical efforts of the WTF, Klaus Schwab, the Biden administration, NATO, international conglomerates, and globalist society, backing this kind of a project. This is

happening in communities all over the United States. Please intercede on our behalf. Thank you.

James Reeb

I'm James Reeb, Sr. My son is on the school board. My wife and I have lived here since 1995. When we moved in 2006, it was incredibly important to us to stay within the bounds of Finneytown South. We feel so lucky to have found this spot. There have always been strong families here. Many kids come back to live here. We have two accomplished sons who attended Finneytown. One chose to come back here and raise a family with his wife, another Finneytown graduate. I was employed 8 years by the Board of Education as a home instructor. My wife and I have been extremely active school volunteers - PTAs, FMPA, Whiz Kids, etc. We've been an ally for every school levy and strong advocates for the school, but we're also against any type of high-density housing on the Whitaker property. We plan to live in this district for the rest of our lives. Finneytown is our home. I'm also concerned about the township. The deed for Warder has no covenants or restrictions, which means they can do what they want to do. We have no input into that process at this point. The Whitaker property is a key part of what might happen to the Warder property. I would like to see us maintain control of this space and therefore control of what might go behind it. If an apartment complex goes here, what would keep them from putting two or four more right behind it? I think that's wrong for our neighborhood, which currently consists of single family homes. I don't see that as being positive. I am requesting the board allow time for public comment at the special meeting to discuss Whitaker property possibilities.

As for the administration contracts, I'm disappointed with the Board and Superintendent for bringing contracts that were not ready to be approved. It seems clear there was not a meeting of the minds. That was not fair to our administrators and left them hanging in the wind. It made our look our board members look really bad.

Scott Haarlammert

My name is Scott Haarlammert. My goal is to reintroduce the Finneytown Schools Educational Foundation (FSEF) to the board, to the administration and to the community. My purpose for being here tonight is to let everybody know that we exist and what we do. We were founded in 1986 as an easy method for donors who want to make donations to the district in a tax advantaged way. We are a 501(c)3, which means we're an official nonprofit organization. We have the infrastructure in place to accept donations, to track donations, and to make sure that donors intents are fulfilled with those donations. We provide paperwork to the donors for filing their taxes. We're a nonprofit organization in Finneytown for the purpose of supporting the school district. We are a private organization, which means we don't have to publicly disclose our donors. That suits a lot of our donors, who want to make anonymous donations. That's not the case with the school district. The school district is a public government organization. Freedom of information and transparency rules require public governments to disclose their donors upon request. We are a complementary organization to the district, not competitive. Together, we can make the Finneytown

> experience greater than either one of us could, individually, for the kids that go here. An example is the FSEF Hall of Fame. It's purpose is to induct people who would elevate the values that Finneytown, not just the athletes. On our website, Wildcat alumni.org, you will find the Hall of Fame doctors, lawyers, athletes, professional musicians, those that have performed on Broadway and in Hollywood movies. We have fortune 500 CEOs. Finneytown is a really unique place and we want to elevate those values for everybody. FSEF also runs a scholarship program that includes the PEM organization. We fund grants, the House System, and AfterProm for the kids. We also run the Alumni Association. It's this last thing that could potentially have the greatest impact on the district. If we could successfully reconnect a substantial proportion of the alumni and reignite their positive memories about what Finneytown meant to them, I think that we can build an incredible financial legacy to endow future generations of Finneytown students. As you build the secondary campus, I believe the alumni could potentially play a crucial role in augmenting what the architects are going to create physically for our kids here in the district. To summarize, the Finneytown Schools Educational Foundation and the district are complementary organizations. Together we can produce some amazing results for the kids here. Over the coming weeks, I'll be reaching out to the board members individually, to provide additional information about the Foundation and how we might work together as we get into this building project. Thanks.

Board Coordination Matters

Mr. Rea, discussed the following items:

- Springfield Township Trustees I was unable to meet with the Township Administrator, Mr. Chris Gilbert, this month.
- Finneytown Unions When speaking on behalf of the union, it is not necessary for an officer to do so during the Public Address. Please let the Board know in advance, and our unions will be given their own time on the agenda to address the Board.

Ms. Lee, discussed the following items:

- Long Range Facilities Committee
 - Met on February 28 with the community in a special meeting to discuss possibilities for the Whitaker site. It was exciting to hear all the different inputs from the community. We will definitely be taking these into account and want to make sure everyone feels heard. The next meeting is April 13.
 - I attended an Ed Visioning session with our leadership team. It was very insightful, identifying different areas of concern to focus on. I liked the next practice versus best practices, Project Based Learning and co-teaching discussions.
- Policy Committee I did not get to meet with the committee, but read over all the recommended updates. I was happy to see the Tobacco policy updated to including vaping.
- Athletic Boosters I attended the most recent meeting. Discussion included: an upcoming concessions conference, a plea for more volunteers, a yet to-be-determined

- event with the community, declining participation in some of the lesser known sports and girls sports.
- Finneytown Athletic Association I did not attend this month. Congratulations to the basketball teams. Eight teams went on to tournament play, with five winning their tournaments. FAA is looking for volunteers.
- Beyond Differences Finneytown met this month. Discussed introducing themselves to the school staff and creating a survey. Minutes from meetings will be forwarded to the District Treasurer.
- Ohio School Boards Association (OSBA)
 - o Board Leadership Institute April 28 and April 29 in Columbus.
 - o Coffee Chat April 18 virtual meeting on the topic: From gender neutral bathrooms to banned books discussions in the education space.

Mr. Gast, discussed the following items:

- Finneytown Schools Educational Foundation
 - o I'm the Board's representative to the education foundation. I was an at-large member before I was a school board member. They're doing great work. They have some funding to help them get a more substantial, and organized, Alumni Association. I think that's really key to what they are planning.
- Beyond Differences Finneytown has been launched.
- Policy Committee Mostly minor wording changes in the update. Vaping language was long overdue. The volunteer policy was changed for additional training.

Mr. Reeb, discussed the following items:

 - My month off of attending FMPA meetings, I plan to attend next month's meeting on 4/10.
 - The high school band attended the OMEA Large Group contest for the first time since 2017, receiving an overall rating of Excellent.
 - On June 3rd the FMPA will be hosting the second annual Golf Outing. Further details will be shared as we get closer to the events.
 - Band Concert On March 15, Grady Laird, after beating cancer, gave his Make-A-Wish (\$5000) to the band program. Thank you for giving back to your community and inspiring us all.
 - Though unable to attend, I would like to give a shout out to our theater program, which recently put on the Addams Family – thank you to our director, Zach Young, and music director, Ariel McCoy, for carrying on our theater program and leading our students in another in the long line of Finneytown's exemplary theater performances.
 - 4/15 Mattress Sale at Finneytown Elementary
- Long Range Facilities Planning
 - Thank you to those of you who shared your thoughts regarding the Whitaker Property here tonight. As I shared at last month's board meeting, I have concerns about the construction of anything over 4 stories or rental housing on the Whitaker Property. I am hopeful that we will be able to reach a decision that

- respects those who live in the neighborhoods around the property and will be most affected by our decision of what to do with the property.
- I am looking forward to the community meeting on April 13th to further talk about the options and future of the Whitaker property. In the meantime, if you any community members would like to discuss my viewpoints with me, you can catch me after the meeting tonight, or send me an email.

Ms. McMullen, discussed the following items:

- Congrats to all the boys and girls basketball teams who won their tournaments last month. A shout out to the FAA coaches and athletic directors for all their hard work.
- I was able to livestream the Black History Celebration at the secondary campus. That was awesome. It was exciting to see so many students showcase their talents and to celebrate Black excellence. It's nice to make all of our students feel appreciated and acknowledged. Thanks to everyone who made that a possibility.
- Primary PTA
 - Had its first celebration, the black history celebration. It was truly a celebration. So many committee members came out and gathered and there were lots of festivities and food vendors. It was an awesome event thanks to Ms. Baker, Ms. Utley, Ms. Theissen, as well as Keisha Allen, Khadijah El-Amin and myself for making this small possibility turned into something special. I look forward to future events and doing that again.
 - I also attended the sixth-grade wax museum. It was phenomenal. The students had buttons. When the buttons were activated, they were able to share different influential black Americans. It was really cool. Thanks to Ms. Gaines for organizing that event.
- Ohio Governor's Youth Art Exhibition Congratulations to the students who placed.

- 1) A lot of our time and decision-making is being spent on our long-range facility planning. We've got to design and build the secondary campus. We are also in partnership with the alumni to hopefully do some great things with the PAC and the gym. We need to be able to adapt our planning as situations change.
- 2) A second major area of focus is the transition from our current building to the new building. It is going to be tight on this campus for about two years. There will be some frustration and everyone's going to have to show some grace and patience as we work through that. The board can be in partnership with that and help us navigate that transition period.
- 3) A third area is long-term planning and allocation of resources in a way that puts us in a good position as we move forward.

Board Member Comments –

Mr. Reeb: I would like to share a few thoughts before we vote on the administrative contracts tonight. In the time since last month's meeting, I have gathered information myself and been provided with additional information from Mr. Oliverio and Dr. Banks that will affect the way that I vote on the administrative contracts presented to us tonight. I'd be happy to share this information if there is anyone who would like to talk about it with me at a time after tonight's meeting.

Regarding last month's meeting, I made a decision based on the information that I had at the time and let Dr. Banks know how I intended to vote before the meeting. When it became clear that things were headed the way that they were, we as a Board, or Dr. Banks, should have requested that we table the discussion/vote for a future meeting or private discussion. This was a caring step that I should have suggested that we take to spare our administrators of going through a painfully slow series of negatory votes and discussion of the minutia of contracts. I would like to take a moment to apologize to those administrators (Anton, Lisa, Grant, Jen, Carol, Eric, Meredith, and Anita) whose contracts we voted on last month. I know the work that you put in daily for our students and staff, often outside the scope of a normal workday (I have seen it myself, as a student, a substitute teacher, sibling of a student, an alumnus, and a community member). You are a valuable part of our district. Thank you for all that you do.

Mr. Rea: I would also like to apologize for the process, not necessarily for my vote, at the last meeting. We should have asked to have them removed from the agenda. I have even more questions about administrative contracts based upon the work that Mr. Reeb has done since the last meeting. I ran on fiscal responsibility. At the last meeting, we were told we have to live within our means, not our wealth. Based on what I've seen, if one or two other districts have something, we have it. I think we should have a reinvestigation of the entire benefit package. It needs to be more in line with what our teachers receive. Retirement packages should be based on remaining sick days, just like teachers, not guaranteed. I think that is being fiscally responsible. That money can go elsewhere, educating kids, getting our state test scores up, and supporting our teachers.

Mr. Gast: I also apologize for the way the process ran last month. As the presiding officer, I should have amended the agenda at a point to stop it.

Mr. Reeb: I knew that there was at least one person that wanted all the contracts to be voted upon separately. I think items 12 through 19 should have been included together as one agenda item.

Ms. Lee: I was not ready to vote in public on these contracts last month. I felt we needed more discussion. My vote was not because I don't care. I do care about our administrators. They are worth great severance packages. The problem is we have to live within our means, and the money should go where we need it most. We've had teachers requesting general education aides. We've asked for more support in reading and math. I think our severance package alone, without the super severance, is amazing. We should be proud of it. It's good for staff. I don't think super severance is being used for recruitment. I don't think it's very efficient. It's given only in the first year of eligibility. If you're a great administrator, I don't want to incentivize you to leave. I know where the majority of the board is, and I am not willing to hold their contracts hostage based off of it.

Mr. Rea: If we can come up with a way to incentivize administrators to stay, I'm all for it. I would want to keep them as long as we can.

RC: Mr. Reeb, yes; Mr. Gast, yes; Ms. Lee, yes; Ms. McMullen, yes; Mr. Rea, no. The president declared the item passed.
