155-23 Ms. McMullen moved, seconded by Ms. Lee, the Board adopted the Resolution Authorizing Solicitation of Bids for the Finneytown Secondary Campus — Building 100 Renovation Project.

The Superintendent requests the Board grant authority to the Treasurer/CFO to solicit bids for the Finneytown Secondary Campus – Building 100 Renovation Project (the "Project").

Background:

- 1. The Board has previously identified a need to renovate Building 100 using ESSER federal grant dollars, and Elevar Design Group ("Elevar") was selected to provide design professional services for the Project.
- 2. The Superintendent and Treasurer/CFO are working with Elevar and legal counsel to prepare the Bidding Package which includes the design drawings/specifications and legal bidding/contract documents for the Project.
- 3. Upon approval of the Board, the Treasurer/CFO will publicly advertise the availability of the Bidding Package and solicit sealed bids, in compliance with R.C. 3313.46 and 2 C.F.R. 320(b)(1).
- 4. On the date specified in the Bidding Documents, or another date arising by addendum, or by operation of law, the Treasurer/CFO will open and tabulate the bids received and determine the lowest responsible bidder; once identified, a contract with the selected bidder will be presented to the Board by the Superintendent for consideration and approval, subject to the Board's right to reject all bids.

The Board of Education resolves as follows:

- 1. The Board authorizes the Treasurer/CFO to publish the required legal notice(s) for the Bidding Package for Project and solicit bids for the work, once the Bidding Package is finalized, and in compliance with R.C. 3313.46 and 2 C.F.R. 320(b)(1).
- 2. The Board further authorizes the Treasurer/CFO to carry out the bid process, in accordance with state and federal law. The bids will be tabulated following such opening, and a report of the tabulation with a recommendation for award of the contract will be provided to the Board by the Superintendent for consideration and approval, subject to the Board's right to reject all bids.
